Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0830; re; Procurement of Fish Feeds, by the Office of the Provincial Agriculturist, New Capitol Site, Tagbilaran City. with an ABC of P 680,250.00;
