



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the PROVINCIAL ENGINEER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0794 re; Procurement of Tubeless Tires & Hub Bearing for the Mitsubishi Strada Plate # SKN - 840 at the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of P 116,900.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CARE AUTOHAUS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
