



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL, LOON, BOHOL** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 220 re: **PROCUREMENT OF VARIOUS JANITORIAL SUPPLIES, LED ENERGY SAVING BULB & 9v BATTERIES** with an ABC of **P 197,603.08.**

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **DELMA ENTERPRISE**, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

- a.) To declare **DELMA ENTERPRISE**, as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. - PHO - 2020 - 163;
- b.) To recommend award to **DELMA ENTERPRISE**, for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 163, in the amount of **ONE HUNDRED NINETY SIX THOUSAND TWO HUNDRED EIGHTY FIVE PESOS ONLY P 196,285.00**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
