



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PRES. CARLOS P. GARCIA MUNICIPAL HOSPITAL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0711; re; Procurement of Additional Materials for the Upgrading of Electrical Power Connection of Pres. C.P.G Hospital at Pitogo, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of P 204,113.50;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that NODAL ELECTRIC TRADE AND SERVICES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

- b.) To recommend award to NODAL ELECTRIC TRADE AND SERVICES for the delivery of goods/services under Negotiated Canvass No. 2020-0542 in the amount of P 202,613.50;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


