

**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the PRES. CARLOS P. GARCIA MUNICIPAL HOSPITAL, PRES. GARCIA, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 121 re: PROCUREMENT OF CCTV, ROLLER BLINDS, STORAGE MEGABOX SOUND SYSTEM, MICROPHONE, ORBIT FAN, WINDOW TYPE AIRCONDITIONING UNIT, DASH E-CAMERA & REFRIGERATOR with an ABC of P 390,000.00;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to B & J COMPUTER SALES AND ELECTRONIC SERVICES INC. in the amount of THREE HUNDRED EIGHTY EIGHT THOUSAND ONE HUNDRED NINETY FOUR PESOS ONLY (P388,194.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 082;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
