WHEREAS, the **PROVINCIAL GENERAL SERVICES OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2020-0720**; re; **Procurement of Blue SSD 3DNAND, Uninterruptible Power Supply & Anti-Virus 2020, by the Provincial General Services Office, New Capitol Compound, Tagbilaran City.** with an ABC of **P 97,000.00**;




