**WHEREAS**, the above Procurement Request was presented to the **BIDS AND AWARDS COMMITTEE** for deliberation and proper action;




**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:



- To recommend approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings




