WHEREAS, the **GOVERNOR'S OFFICE – SPECIAL PROJECTS SECTION** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2021-C-041** re: **PROVISION OF ROOM ACCOMMODATION AND MEALS FOR VISITING DIGNITARIES, VIPs AND GUESTS** with an ABC of **₱ 100, 000.00**;
