

## CONTRACT AGREEMENT

THIS AGREEMENT, made this 21<sup>st</sup> day of April, 2021 between Office of the Provincial Agriculturist of Provincial Government of Bohol (hereinafter called the "Entity") and ALTA CEBU VILLAGE GARDEN RESORT, INC. of Sitio Mambu, San Isidro, Baclayon, Bohol (hereinafter called the "the Supplier").
