

**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 395 re: PROCUREMENT OF I.T. EQUIPMENTS AND COMPUTER TABLE with an ABC of P 472,510.00;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:



- b.) To recommend award to B & J COMPUTER SALES AND ELECTRONIC SERVICES INC. in the amount of FOUR HUNDRED SEVENTY ONE THOUSAND FIVE HUNDRED PESOS ONLY (P 471,500.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 309;


