WHEREAS, the <u>PROVINCIAL HEALTH OFFICE</u>, <u>NEW CAPITOL BUILDING</u>, <u>COGON DISTRICT</u>, <u>TAGBILARAN CITY</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2020 - 321 re</u>: <u>PROCUREMENT OF MOBILE PEDESTAL</u> ABC of <u>P 99,000.00</u>;
