THIS AGREEMENT, made this 25<sup>TH</sup> day of March, 2021 between BOHOL EMPLOYMENT AND PLACEMENT OFFICE of Provincial Government of Bohol (hereinafter called the "Entity") and CASA REY FRANCIS PENSION HOUSE AND RESTAURANT of 0118 V.P. Inting St., Poblacion I, Tagbilaran City, Bohol (hereinafter called the "the Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **CATERING SERVICES TO BE USED FOR THE TRAININGS AND SESSIONS OF LAUM BOHOL PROGRAM - ABIBA KEY COMPONENT** and has been accepted a Bid by the Supplier for the supply of those goods and services in the sum of **P 268,920.00** in ***Two Hundred Sixty-Eight Thousand Nine Hundred Twenty Pesos Only.***
