



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL ENGINEER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0567 re; Procurement of Various Hardware, & Construction Materials for the Repair of Pandol Bridge at Pandol - Fatima Road, Corella, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of P 388,038.31;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that DBP CONSTRUCTION CORPORATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of DBP CONSTRUCTION CORPORATION including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation: DBP CONSTRUCTION CORPORATION has been found to be ELIGIBLE and its quotation, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare DBP CONSTRUCTION CORPORATION as the supplier, with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2020-0425;
- b.) To recommend award to DBP CONSTRUCTION CORPORATION for the delivery of goods/services under Negotiated Canvass No. 2020-0425 in the amount of P 387,858.31;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
