WHEREAS, the **BIDS AND AWARDS COMMITTEE** passed BAC Resolution No. 2021-107 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **CONG. SIMEON G. TORIBIO MEMORIAL HOSPITAL, CARMEN, BOHOL** in undertaking Procurement Request under **PR No. – PHO – 2021 - 052** re: **PROVISION OF CCTV NETWORK WITH INSTALLATION AND PAGING SYSTEM** with an ABC of **P 300,000.00**;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **B & J COMPUTER SALES AND ELECTRONIC SERVICES INC.**, offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- b. To recommend award **B & J COMPUTER SALES AND ELECTRONIC SERVICES INC.** in the amount of **TWO HUNDRED NINETY EIGHT THOUSAND FOUR HUNDRED PESOS ONLY (P 298,400.00)**; for the Delivery of Goods under **Negotiated Canvass No. – PHO – 2021 - 058 (2<sup>nd</sup> failure of bidding)**;
- c. To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.


