THIS AGREEMENT made this 22 JUN 2021 between the **PROVINCIAL GOVERNMENT OF BOHOL**, Provincial Capitol, Lino 3 Chatto Hall, Cogon District, Tagbilaran City, Bohol, (hereinafter called "the Entity") of the one part and **SKETCHES & PLOTS FURNITURE & FIXTURES ENTERPRISE**, of Blk 12 Lot 4, Magdaleneville II Subdivision, Brgy. Mandalagan, Bacolod City (hereinafter called "the Contractor") of the other part.

Mandalagan, Bacolod City, execute (hereinafter called " the Works") and the Entity has accepted the Bid for (PHP 8,213,289.00) **Eight Million Two Hundred Thirteen Thousand Two Hundred Eighty Nine Pesos Only** by the Contractor for the execution and completion of said works and to remedy any defects therein.
