WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0294 series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the GOVERNOR'S OFFICE in undertaking Procurement Request under PR No. 2021-0258 re: Procurement of Fuel Diesel & Unleaded for use during the Logistical Support and Resource Counterpart for Special Operation including Emergency or Crisis Response Activities, Maintenance of Law and Order and Surveillance Activities. Assigned by Governor's Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 899,985.68



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:



- To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




