



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 126 re: PROCUREMENT OF PLAQUES ABC of P 348,500.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CENTROID PRINTSHOP offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of CENTROID PRINTSHOP including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid CENTROID PRINTSHOP has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare CENTROID PRINTSHOP as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount **P 339,572.00** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. - PHO - 2021 - 097; Note: To be awarded by LOT;
- b.) To recommend award to CENTROID PRINTSHOP in the amount of **THREE HUNDRED THIRTY NINE THOUSAND FIVE HUNDRED SEVENTY TWO THOUSAND PESOS ONLY (P 339,572.00)** for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 097;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings






