WHEREAS the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0639 series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE SANGGUNIANG PANLALAWIGAN – SECRETARIAT in undertaking Procurement Request under PR No. 2021-0502 re: Procurement of Engine Oil, Storage Battery & Vehicle Spare Parts, by the Office of the Sangguniang Panlalawigan - Secretariat, Bohol Provincial Capitol, Cocon District, Tagbilaran City, with an ABC of P 26,980.00;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:
