



BAC Resolution Recommending the Use of Alternative Mode of through Direct Contracting, Declaring Single Calculated and Responsive Bid and Recommending Approval

WHEREAS, the **Chief of the CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL, LOON, BOHOL** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of the goods under Purchase Request No. - **PHO - 2021 - 261** re: **PROCUREMENT OF DRAIN MAINTENANCE DISINFECTANT AND HANDS ON LOTION** with an ABC of **P 133,000.00**;




