

## BAC Resolution Declaring SCRQ through Negotiates Waste of and Recommending Award

RESOLUTION NO. <u>202</u>-229 Series of 2021

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. PHO – 2021 – 258 re: PROCUREMENT OF NOVEL CORONAVIRUS (2019- nCOV), SAMPLE STORAGE REAGENT (UNIVERSAL TRANSPORT MEDIA) & SAMPLE RELEASE REAGENT (EXTRACTION KIT) with an ABC of P9,870,720.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that <u>OMNIBUS BIO-MEDICAL SYSTEMS INC.</u> offered the single price quotation as reflected in the Abstract of Bids Proposals;

- b). To recommend award to <u>OMNIBUS BIO-MEDICAL SYSTEMS INC.</u> for the delivery of goods of the aforementioned request in the amount of <u>P 9,870,720.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
