WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. PHO – 2021 – 258 re: PROCUREMENT OF NOVEL CORONAVIRUS (2019- nCOV), SAMPLE STORAGE REAGENT (UNIVERSAL TRANSPORT MEDIA) & SAMPLE RELEASE REAGENT (EXTRACTION KIT) with an ABC of ₱ 9,870,720.00;




