

BAC Resolution Declaring SCRQ through Negotiated Mode of Procurement - Emergency Case
and Recommending Award

RESOLUTION NO. _____ Series of 2021

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. PHO – 2021 – 291 re: PROCUREMENT OF NOVEL CORONAVIRUS (2019- nCOV), SAMPLE STORAGE REAGENT (UNIVERSAL TRANSPORT MEDIA) & SAMPLE RELEASE REAGENT (EXTRACTION KIT) with an ABC of P 5,820,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that <u>OMNIBUS BIO-MEDICAL SYSTEMS INC.</u> offered the single price quotation as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.2 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>OMNIBUS BIO-MEDICAL SYSTEMS INC.</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>OMNIBUS BIO-MEDICAL SYSTEMS INC.</u> has been found to be <u>ELIGIBLE</u> and its bid, <u>RESPONSIVE</u>;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- b). To recommend award to <u>OMNIBUS BIO-MEDICAL SYSTEMS INC.</u> for the delivery of goods of the aforementioned request in the amount of <u>P 5,820,000.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
