WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0703 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL DISASTER RISK REDUCTION & MANAGEMENT OFFICE in undertaking Procurement Request under PR No. 2021-0449 re: Procurement of Various Computer Components & Materials, by the Provincial Disaster Risk Reduction & Management Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol, with an ABC of ₱ 247,671.60;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC., offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
