
WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. _____ series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the Provincial Health Office, New Capitol Building, Cogon District, Tagbilaran City in undertaking Procurement Request under PR No. - PHO - 2021 - 128 re: PROCUREMENT OF EQUINE IMMUNOGLOBULIN FOR THE ANIMAL BITE TREATMENT with an ABC of P 4,597,200.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that LEEAN MEDICAL & SURGICAL SUPPLY offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;



- a. To declare LEEAN MEDICAL & SURGICAL SUPPLY as the supplier with the Lowest and Responsive Price Quotation in the amount of P 4,597,200.00 under Negotiated Canvass No. - PHO - 2021 - 168 (2nd failure of bidding);
 - b. To recommend award LEEAN MEDICAL & SURGICAL SUPPLY in the amount of FOUR MILLION FIVE HUNDRED NINETY SEVEN THOUSAND TWO HUNDRED PESOS ONLY (P 4,597,200.00) for the Delivery of Goods under Negotiated Canvass No. - PHO - 2021 - 168 (2nd failure of bidding);
 - c. To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.






