WHEREAS, the **PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. 2021 – 381 re: Procurement of various MEDICAL SUPPLIES with an ABC of P 909,621.00;




