

EWC Resolution Recommending the Line of Negotiated Procurement Strongs Small Value, Declaring Lowest Calculated and Responsive Quantation and Recommending Approval

RESOLUTION NO. (C)-14/2. Series of 2021

WHEREAS the OFFICE OF THE SP-BOARD MEMBER ALDNER R. DAMALERIO of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0684; re; Procurement of Various Spare Parts for 120,000km/ Check-up of Engine & Repair of Aircon/Replacement of Defective Parts of Vehicle SKY - 349, by the SP-BM Aldner R. Damalerio, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol. with an ABC of P 74,125.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>TAGBILARAN CITY TYRE SALES & SERVICE CENTER</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;

- b.) To recommend award to <u>TAGBILARAN CITY TYRE SALES & SERVICE CENTER</u> for the delivery of goods/services under Negotiated Canvass No. <u>2021-0486</u> in the amount of <u>P 74,056.00</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
