



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS the OFFICE OF THE SP-BOARD MEMBER ALDNER R. DAMALERIO of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0684, re: Procurement of Various Spare Parts for 120,000km. Check-up of Engine & Repair of Aircon/Replacement of Defective Parts of Vehicle SKY - 349, by the SP-BM Aldner R. Damalerio, Bohol Provincial Capitol Building, Cocon District, Tagbilaran City, Bohol, with an ABC of P 74,125.00;


