



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE SP-BOARD MEMBER FRANS GELAINE C. GARCIA of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0687; re; Procurement of Various Vehicle Spare Parts Supplies with Labor for Vehicle SKY - 369, by the Board Member Frans Gelaine C. Garcia, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol, with an ABC of P 198,680.00

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE & SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;
