

BAC Resolution Recommending the Use of Negotiated Procurement the Quotation and Recommend

RESOLUTION NO. 21 159 Series of 2021

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0718, re; Procurement of Diesel by the Office of the Provincial Agriculturist Bohol Provincial Capital Building, Cogon District, Tagbilaran City, Bohol. with an ABC of P 274,217.88;
