WHEREAS, THE OFFICE OF THE GOVERNOR - SPECIAL PROJECT SECTION, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0759; re: Procurement of Van Rental & Coaster, by the Office of the Governor - Special Project Section, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 91,000.00;
