



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL PLANNING AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0804; re; Procurement of Van Rental for Project Monitoring & Evaluation of Operation of the Bohol Energy Development Advisory Group (BEDAG) Data Gathering/Validation & Delivery of Communication to Different LGUs, by the Provincial Planning and Development Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC P 69,500.00.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


