



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the **PROVINCIAL PLANNING AND DEVELOPMENT OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. 2021-0807; re: Procurement of Vehicle Rental for Monitoring, Evaluation of CBMS & SDGs Data Gathering/Validation & Project Monitoring & Delivery of Communication to Different LGUs, by the Provincial Planning and Development Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC P 69,500.00.



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:






