BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>PROVINCIAL PLANNING AND DEVELOPMENT OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2021-0807</u> re; <u>Procurement of Vehicle Rental for Monitoring, Evaluation of CBMS & SDGs Data Gathering/Validation & Project Monitoring & Delivery of Communication to Different LGUs, by the Provincial Planning and Development Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC <u>P 69,500.00.</u></u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BOHOL TOURIST MULTI-PURPOSE</u> <u>COOPERATIVE</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **BOHOL TOURIST MULTI-PURPOSE COOPERATIVE** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **BOHOL TOURIST MULTI-PURPOSE COOPERATIVE** has been found to be ELIGIBLE and its bid, RESPONSIVE;
