WHEREAS, the CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL, LOON, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 - 281 re: Procurement of LABORATORY SUPPLIES & REAGENTS with an ABC of P 140,840.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that DEXTEL TRADING offered the Single price quotation as reflected in the Abstract of Bid Quotations,
