WHEREAS, the **MARIBOJOC COMMUNITY HOSPITAL, MARIBOJOC, BOHOL** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. **2021 – 380** re: **PROCUREMENT OF MEDICAL AND LABORATORY SUPPLIES** with an ABC of **P 307,500.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **DEXTEL TRADING** offered the Single price quotation as reflected in the Abstract of Bid Quotations,
