Declaring LPRC and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0953 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode, and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **OFFICE OF THE PROVINCIAL VETERINARIAN** in undertaking Procurement Request under PR No. 2021-0557, re: Procurement of Supply & Installation of Stainless Build-Up Signage, by the Office of the Provincial Veterinarian, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of ₱ 92,500.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **ADS & PRINTS REPUBLIQ** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, **ADS & PRINTS REPUBLIQ** has been found to be ELIGIBLE and its quotation, RESPONSIVE;

- b). To recommend award to **ADS & PRINTS REPUBLIQ** or delivery of goods/services under Negotiated Canvass No. 2021-0450 (2nd Failure) in the amount of ₱ 92,350.00;
- c). To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.


