Declaring LDRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. \_\_\_\_\_ series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL ENGINEER'S OFFICE in undertaking Procurement Request under PR No. 2021-0673 re; Procurement of Various IT Equipment, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City, with an ABC of ₱ 156,450.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC., offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

- b). To recommend award to B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC. or delivery of goods/services under Negotiated Canvass No. 2021-0530 (2nd Failure) in the amount of ₱ 150,528.00;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
