



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

CEPEDOZA of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0766; re; Procurement of Vehicle Repair, Maintenance and Spare Parts for the Service Vehicle Mitsubishi /Strada-Sky 356, by the Office of the SP - Board Member Romulo G. Cepedoza, New Capitol Compound, Tagbilaran City, with an ABC of P 55,905.00;



- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




