WHEREAS, the **PROVINCIAL GENERAL SERVICES OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. **2021-0148** re: Procurement of Siphoning of Septage/sludge, Hauling and Treatment of Septic Tank for used at Provincial General Services Office, Bohol Provincial Capitol Building, Cocon District, Tagbilaran City with an ABC of P 91,800.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:




