WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-1100 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE SP-BOARD MEMBER LUCILLE YAP LAGUNAY in undertaking Procurement Request under PR No. 2021-0692 re: Procurement of Various Office Supplies, Sporting Goods & Housekeeping Supplies, by the Office of the SP-Board Member Lucille Yap Lagunay, Bohol Provincial Capitol, Cogon District, Tagbilaran City. with an ABC of ₱ 139,494.10;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ST. JUDE PRESS MARKETING AND SUPPLIES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
