WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-1148 series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **PROVINCIAL GENERAL SERVICES OFFICE** in undertaking Procurement Request under PR No. 2021-0746 re: Procurement of Various Spare Parts Supplies, by the Provincial General Services Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of ₱ 144,015.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **TAGBILARAN CITY TYRE SALES & SERVICE CENTER** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
