BAC Resolution Declaring SCRQ through Negotiated Mode of Procurement – Emergency Cases and Recommending Award

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TABILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. PHO – 2021 – 456 re: PROCUREMENT OF MEDICINES FOR DISTRIBUTION TO ALL BARANGAYS IN THE PGBH with an ABC of P 9,997,635.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that DEXTEL TRADING. offered the single price quotation as reflected in the Abstract of Bids Proposals;
