

BAC Resolution Declaring SCRC through Negotiated Mode of Procurement – Emergency Cases and Recommending Award

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TABILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. PHO – 2021 – 458 re: PROCUREMENT OF BARANGAY COVID KITS TO ALL BARANGAYS OF THE PROVINCE OF BOHOL with an ABC of ₱ 84,250,250.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that DEXTEL TRADING. offered the single price quotation as reflected in the Abstract of Bids Proposals;

- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
