

BAC Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-1032 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the EDUCATION DEVELOPMENT CENTER in undertaking Procurement Request under PR No. 2021-0090 re: Concreting of Pathway at Tubigon West Central High School at Poooc Oriental, Tubigon, Bohol, by the Education Development Center, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol. with an ABC of ₱ 271,124.50;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 3N CONSTRUCTION & SUPPLY offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals;




