BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0001 re: PROCUREMENT OF SARDINES, MEATLOAF, CELLOPHANE & STRAW BINDER BIG BY THE OFFICE OF THE PROVINCIAL SOCIAL WELFARE DEVELOPMENT, TAMBLOT STREET, TAGBILARAN CITY with an ABC of P 16,215,300.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ALTURAS SUPERMARKET CORP. and PRIM E CONSTRUCTION SUPPLIES TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,

WHEREAS, under Section 53.2 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of ALTURAS SUPERMARKET CORP. and PRIM E CONSTRUCTION SUPPLIES TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, ALTURAS SUPERMARKET CORP. offered P 13, 513,475.00 for item no. 1 of 2 and PRIM E CONSTRUCTION SUPPLIES TRADING offered P 196,273.75 for item no. 3, 4 & 5 has been found to be ELIGIBLE and its bid, RESPONSIVE;
