



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE SP-BOARD MEMBER LUCILLE Y. LAGUNAY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0929; re; Procurement of Tires for Mitsubishi Strada with plate No. SKY - 339, by the Office of the Board Member Lucille Y. Lagunay, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol, with an ABC of P 64,875.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES & SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
