WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 182 re: PROCUREMENT OF PANEL LIGHT with an ABC of P74,250.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that D18TH HI-WAY MARKETING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings


