WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-032 re: PROCUREMENT OF CATERING SERVICES FOR POST ODETTE AGRO FISHERY DAMAGE ASSESSMENT AND REHABILITATION CONSULTATION with an ABC of ₱ 840, 000.00;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:
