



BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL HEALTH OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-047 re: PROVISION OF RENTAL OF VENUE FOR THE BARANGAY HEALTH WORKERS GENERAL ASSEMBLY CAN HOLD A MINIMUM OF 1,400 PERSONS with an ABC of ₱ 225, 000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PANDA TEA GARDEN SUITES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
