



BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL PLANNING DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-043 re: PROVISION OF MEALS & SNACKS DURING THE 2022 PROVINCIAL DEVELOPMENT COUNCIL EXECUTIVE COMMITTEE MEETINGS FOR 1ST & 2ND QUARTERS with an ABC of ₱ 141, 000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that REYNA'S THE HAVEN & GARDENS FOOD CATERING SERVICES, INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
